New With this Release...

* In order to retain the CD-ROM to one volume, Tax Year 99 revision date products and some of the Internal Revenue Bulletins were removed from the CD-ROM. Users may obtain these products from either the 2002 (Rel 1 CD or earlier) CD-ROM or from the IRS internet site at www.irs.gov.

* The CD-ROM contains Adobe Acrobat Fill-in Approval 5.05. CD-ROM users can enter data on tax forms, print out the forms with the data in them and save them to a disk. Please note that the default navigation tabs on the left side of the window do not have functionality for IRS pdf files.

* HTML versions of the instructions were added this year. A standard internet browser is needed for viewing and searching. These browsers are freely available on the internet.

The software volume number used to identify the CD-ROM was adjusted so that the first release and the final release will now carry the same number - 2002. This was done so that users would not need to reinstall the software. However, a different volume number will be used in the event that changes to executable files are needed.

Other Important Information...

To read PDF files, you must install the Adobe Acrobat software for Windows or Macintosh found on this CD or already have Acrobat or an Acrobat reader installed on your computer system. Acrobat readers are available directly from Adobe Systems Incorporated for Macintosh and Windows systems.

CD-ROM Basic Navigation:

To view and search the PDF files on this CD, PDF navigation files with cross-document links and indexes were created using Adobe Acrobat and Acrobat Catalog software. The CD-ROM provides full text search capabilities for the PDF files.

Main CD-ROM Files and their contents:

(TXT files are located in D:\IRSHelp\, where D: is your CD-ROM drive.)

1. 02Readme.TXT - Contains general information about this CD-ROM.
2. 2002List.PDF - Contains a master list of only the current PDF files with cross document links built in. There are over 900 different products in this list.
3. 2002List.HTML - HTML version of master list of only the

current PDF files. (You can use your own word processor to display, edit, and print this list.)
